The meeting was called to order by Secretary Peter VanErkel.

Jon made a motion to approve the October 15<sup>th</sup> 2019 minutes as submitted seconded by Jeff and carried.

An application for permit was submitted by Casey Staloch to tile in tract # 52489section 33 Newry twsp Freeborn Cty T104R19. Adam Bishop is the Contractor for this project. Jon made a motion to grant this permit seconded by Dave and carried. Permit # 11-07-19.

Steve Penkava reports Moscow Twsp is planning to install the culvert on 890<sup>th</sup> Ave next week. The pipe is on site and they are waiting for better weather.

Dave Vanderploeg's Manager position is up for reappointment. Freeborn County has their next meeting in December.

Steve Lawler report on the Multipurpose Drainage grant. The TCWD has committed to cost share for the practices being constructed in the headslope area of CD#8. Several practices have been finished and he expects the Freeborn SWCD to request payments from TCWD in early December to finalize the projects.
