Turtle Creek Watershed District
October 21st, 2025

The Turtle Creek Watershed Board of Managers met at the government Center in Hollandale, Minnesota. Present were Jeff Ravenhorst, Jon Erichson, Michelle O'Connor, Dave Vanderploeg, Peter VanErkel, Steve Penkava and James Fett.

Also attending the meeting were Scott Thompson, Mark Behrends, Dawn Kaasa—2nd District County Commissioner, and Jeanine Vorland.

Dave made a motion to accept the September 2025 minutes as presented seconded by Jeff and carried.

The Treasurers report showed \$207,994.62 in checking and \$212,982.69 in the CD. Jon made a motion to accept this report subject to audit seconded by Pete and carried.
